# MINUTES OF THE MEETING OF THE EXECUTIVE COMMITTEE May 19, 2020 Meeting by Conference Call

### PRESENT:

- Dr. Borenstein called the meeting to order. The following issues were discussed:
- 1. Minutes. The minutes for the February 25, 2020 Executive Committee meeting were reviewed and accepted.
- 2. Dues Comparison Statement. The Committee reviewed a dues comparison statement for the months October through May for the years 2010 through 2020. Mr. Stein reported that, even with the 2020 dues increase, there has been a substantial reduction in dues revenue for March and April, although this may be due to a temporary delay in dues payments. We will continue to monitor and consider contingency plans if the situation worsens.
- 3. Albany Report. In addition to the written Albany Report that was included in the meeting packet, Mr. Gallo reported on the following:

Mr. Gallo reported that the Senate has indicated that they will hold a virtual session on May 26<sup>th</sup> and 27<sup>th</sup>, to address COVID-19 related measures. There are currently approximately 400 bills related to COVID-19.

Mr. Gallo reported on the financial plan released by New York's Division of the Budget in April.

Mr. Gallo gave a COVID-19 update based on the Governor's daily briefings and reported on counties that will begin reopening.

Mr. Gallo also reported that Governor Cuomo has been drawing attention to the mental health impact of COVID-19. OMH announced that they will begin a series of public service

announcements to raise awareness of the Emotional Support Helpline. Governor Cuomo has highlighted The Mental Health Coalition, an initiative launched by his brother-in-law, fashion designer Kenneth Cole. The Coalition focuses on removing the stigma surrounding mental health.

MSSNY has established a peer-to-peer help line specifically for physicians who are experiencing COVID-19 related stress. MSSNY will be hosting a webinar on May 20, 2020 on Mental Health and COVID-19 for health professionals conducted by Craig Katz, MD.

Mr. Gallo reported on the OMH proposed rule regarding changes to clinic treatment plans.

Mr. Gallo updated the Committee on NYSPA's Veterans Mental Health-Primary Care Training Initiative. Mr. Gallo stated that webinar recordings of the PTSD and Suicide presentations are being finalized and will soon be uploaded to the NYSPA website. In addition, VMH-PCTI presentations covering women's issues and military culture have been finalized and details are being worked out for train-the-trainer sessions for these new tracks.

Mr. Gallo noted that a page of COVID-19 resources and links was included with the written Albany report.

4. New Business. Mr. Stein reported that NYSPA will be sending out a member survey to get a read on the impact of COVID-19 on psychiatrists. Mr. Stein invited Committee members to review the copy of the draft survey included in the packet and to send any suggestions for additional questions to the NYSPA office.

Dr. Borenstein reported that he received an e-mail from Dr. Benson praising Dr. Vito for the excellent job he does serving on the PAC Board and stating that he would like to add another New York member to the Board. Dr. Borenstein asked the Committee to send suggestions to him.

The Committee discussed whether to hold the Fall NYSPA/Area Council meeting virtually. The Committee will discuss this further at the June Executive Committee Meeting.

There being no further business, the meeting was adjourned.

# ALBANY REPORT FOR EXECUTIVE COMMITTEE MEETING TUESDAY, JUNE 16, 2020

### I. Legislative Session

Since our last Albany Report, the Legislature returned to session (virtually) twice. On the first occasion, the Legislature passed a package of legislation to address the COVID-19 pandemic. A detailed listing summarizing the COVID-19 related bills passed by the Legislature is enclosed along with this Albany Report. On the second occasion, the Legislature passed a package of police and criminal justice reform bills, including a law to allow for disclosure of law enforcement disciplinary records, prohibit chokeholds, prohibit false 911 calls, and codify an executive order to authorize the Attorney General to investigate the death of an unarmed individual by police. A detailed listing summarizing the police and criminal justice reform-related bills passed by the Legislature is also enclosed. In the Legislature's second return earlier this month, a number of local bills needed (known as home rule) were also passed.

Session Statistics: For those who keep track of such things: Since January 1, 2019, the start of the 2-year term of the Legislature through Tuesday, June 16, 2020, 16,282 bills were introduced. Since January 1, 2020 through June 16, 2020, the Senate passed 433 bills, while the Assembly passed 338 bills. Of the 193 bills that passed both houses this year: 102 have been signed into law, 3 have been vetoed, 21 are on Governor's desk for consideration, and 70 have not yet been delivered to the Governor. As a comparison, taking into account the same time period, 935 bills passed both houses in 2019 compared to 641 in 2018, 606 in 2017, 618 in 2016, 718 bills in 2015, 658 in 2014, and 650 in 2013. The number of bills that passed both houses to date currently in 2020 is a historic low owing to the disruption of the Legislative Session by COVID-19.

### II. FY20-21 Enacted State Budget: Status Update on Potential Cuts

As we prepare this report, there is one matter that may cause the Legislature to return sooner rather than later – the State budget – as a \$13 billion deficit looms in the enacted budget. Governor Cuomo and the Legislature are anxiously waiting to see if President Trump and Congress come to terms on federal legislation that would provide aid to state and local governments. In the absence of additional federal aid, Governor Cuomo has stated on multiple occasions a 20% cut in aid to schools, hospitals, and local governments would be needed to balance the state budget.

On Medicaid, the Department of Health recently announced and published notice in the NYS Register on the implementation of 1.5% across the ate board cut to Medicaid payments effective for dates of services on or after April 2, 2020. The reduction applies for fee-for-service payments and Medicaid Managed Care plans will see a 1.5% reduction to premium rates effective April 2, 2020. Payments had already been reduced across the board by 1% from January 1 – March 31, 2020 which means this latest reduction is an additional 0.5%. The Medicaid Redesign Team had recommended a 1.875% reduction. Of importance and note, the announcement lists those payments that are exempted from the 1.5% reduction including payments whereby federal

law precludes such reduction as well as payments pursuant to Article 32, Article 31 and Article 16 of the Mental Hygiene Law. The listing of payments subject to the reduction:

On Monday, June 15, 2020, NYS Comptroller Tom DiNapoli released the May cash report, which found State tax revenues were down \$767 million or 19.7% during the month. As stated in our May Albany Report, the enacted state budget for FY 2020-2021 gives Division of Budget authority to make reductions when the budget is deemed out of balance. The DOB powers are "activated if actual tax receipts are less than 99 percent of estimated tax receipts, or actual disbursements are more than 101 percent of estimated disbursements, as measured at three points during the year – April 1-April 30; May 1-June 30; and, July 1-December 31." We will continue to monitor any developments and provide further updates.

# III. COVID-19 Updates

The latest developments from Governor Cuomo's briefing:

- Hospitals will be allowed to accept visitors at their discretion. Hospitals must follow state guidelines, including time limited visits and requiring visitors to wear PPE and be subject to symptom and temperature checks.
- Beginning on Friday (June 19, 2020), group homes certified by OPWDD will be authorized to begin visitations. Group homes must notify the State and follow state guidelines including requiring visitors to wear masks and be subject to temperature checks.
- Visitors are still not permitted at nursing homes.
- Five regions have already entered Phase Three Central New York, the Finger Lakes, the Mohawk Valley, the North Country, and the Southern Tier.
- Western NY entered Phase Three today (Tuesday, June 16).
- Capital District is expected to enter Phase Three Tomorrow (Wednesday, June 17).
- New Executive Order authorizing gatherings of up to 25 people will be allowed in Phase Three of reopening, up from the limit of 10.

# IV. Efforts to Extend Telehealth Provisions Implemented During COVID-19 Public Health Emergency

NYSPA along with The National Association of Social Work – NYC Chapter, the NYS Clinical Society for Social Work, the and the NYS Psychological Association have drafted a joint letter urging Governor Cuomo to extend the expansion of authority for mental health providers to continue telehealth service delivery for patients with Medicaid and commercial insurance at least, period of twelve months after the last region of the state is fully operational. *ACTION ITEM: We have enclosed the proposed letter for review and approval by the Executive Committee and determination of who will sign it from NYSPA*.

Simultaneously, MSSNY and the medical specialties have also agreed to advocate for an extension of the telehealth provisions authorized during COVID-19 and plan to prepare a joint letter and also pursue a conference call with the Department of Financial Services. MSSNY and the medical specialties plan to build momentum for an extension of the telehealth provisions through sustained electronic advocacy and virtual meetings with the members of the Legislature over the summer and fall. To start, NY Chapter of the American College of Physicians (NYACP) is also planning to have their members send a prepared letter to their Senators and Assemblymembers and is also coordinating several virtual legislative visits on Friday, June 19 attended by pertinent committee chairs of NYACP. NYACP will share the prepared letter with the other specialties for their use and adaptation.

Last week, MSSNY and the specialties held a brainstorming session to review some of the associated issues with telehealth that need further study and potential advocacy including the need for payment parity with face-to-face as well as health disparities.

We will provide further updates as they develop including efforts to mobilize NYSPA members on the issue.

### V. Legislation of Note

- S.8216 (Metzger)/A.10404-A (Rosenthal) -- This legislation amends the definition of telehealth under the Public Health
  Law to include audio-only telephone or video-only communications and also permit coverage and reimbursement under
  New York's Medicaid Program contingent upon federal financial participation. This was among the COVID-19 bills
  passed by the Legislature. STATUS UPDATE: Bill is on Governor Cuomo's desk, who must act by June 17, 2020.
  NYSPA has submitted a letter in support (enclosed).
- S.6601-B (Bailey)A.8226-B (Fernandez) Provides that when a person is under arrest or otherwise in custody of a police officer, peace officer or other law enforcement representative or entity, such officer, representative or entity shall have a duty to provide attention to the medical and mental health needs of such person. This was among the police and criminal justice reforms bills passed by the Legislature. STATUS UPDATE: Governor Cuomo signed the bill into law on Monday, June 15, 2020 as Chapter 103 of the Laws of 2020.
- A.10299 (Rosenthal)/NO SAME AS The bill would decriminalize psilocybin, the active ingredient colloquially referred to as "magic mushrooms." The sponsor's memo notes the FDA has designated the use of psilocybin as a "break- through therapy for treatment-resistant depression" and many cities had begun decriminalizing the use and possession of psilocybin. STATUS UPDATE: The bill was referred to the Assembly Health Committee.
- A10629 (Gunther)/NO SAME AS The will would establish the Frontline Workers Trauma Informed Care Advisory Council within the OMH, consisting of certain commissioners or designees and twenty-one members, to assure the trauma-related behavioral health needs of essential workers during COVID-19 are addressed. This is an effort championed by the Mental Health Association in NYS. The advisory committee would be tasked with preparing and issuing a report with recommendations to the Legislature by December 1, 2020. STATUS UPDATE: The bill was referred to the Assembly Health Committee.

### VI. Status Update on Legislation Tracked

COVID-19 disrupted normal legislative activity and consideration of bills on the calendar as well as perennial bills. Of interest for NYSPA, here is listing of the bills that remained in committee in both houses and/or passed one House.

- S.7758 (HARCKHAM); A.6132 (MCDONALD) Authorizes psychologists to prescribe. STATUS: In Senate and Assembly Higher Education Committees.
- S.4848 (BRESLIN)/A.3830 (MCDONALD) The bill would authorize pharmacists to administer injectable medications for mental health and substance use disorders "...as prescribed or ordered by a licensed prescriber in this state and in accordance with regulations promulgated by the commissioner in consultation with the board of pharmacy." STATUS: Although it passed the Senate in 2019, the bill remains in Senate and Assembly Higher Education Committees.
- S.4967-A (SKOUFIS)/A.6389-A (PEOPLES-STOKES) The bill would amend State Education Law to authorize applied behavior analysts to provide applied behavioral analysis treatment to any individual (youth or adult) without a diagnosis of autism spectrum disorders or related disorders. STATUS: In Senate and Assembly Higher Education Committees.
- S.6128 (SAVINO)/A.6377-A (PEOPLES-STOKES) Omnibus legislation that would authorize a number of non-physician health care professionals to form multidisciplinary partnerships, limited liability companies, and professional service corporations with physicians. STATUS: The bill is the Senate Corporations, Authorities and Commissions Committee and the Assembly Higher Education Committee.
- S.2372 (CARLUCCI)/A.4847 (STECK) Duty to Protect for Mental Health Practitioners STATUS: The bills are in the Senate and Assembly Mental Health Committees.
- S.3947 (SAVINO)/A.2694 (PAULIN) Medical Aid in Dying STATUS: Bills are in Senate and Assembly Health Committees.
- S.6516 (BAILEY)/A.5475 (FERNANDEZ) Requires two qualified psychiatrists to be employed by each school district to perform and coordinate the provision of mental health services in the public schools. STATUS: The bill is in the Senate and Assembly Education Committees.
- S.3462 (RIVERA)/A.2393 (GOTTFRIED) Physician Collective Negotiation STATUS: The bill is in the Senate Health Committee and Assembly Ways & Means Committee.
- S.3577-A (Rivera)/A.5248-A (Gottfried) New York Health Act (Single Payer Bill) STATUS: The bill is in the Senate and Assembly Health Committees.
- S.2599 (PARKER)/A.3439 (WALKER) Requires DOH to conduct study on drugs prescribed to school-age children with ADD and ADHD (calls for focus on harmful side effects). STATUS: The bill is in the Senate and Assembly Health Committees.
- S.5441 (SEPULVEDA)/A.1033 (GOTTFRIED) Use of Psychotropic Medications in Nursing Homes STATUS: Passed Assembly. The bill is in Senate Health Committee.

# VII. DFS Draft Proposed Regulation: MH/SUD Parity Compliance Programs

DFS has posted draft regulation that is scheduled to be published later this month in the NYS Register for a 60-day public comment period requiring insurers and health plans subject to NYS Insurance Law Sections 3126, 3221 and 43030 to establish mental health and substance use disorder parity compliance programs with certain enumerated requirements. In summary, the proposed regulations require that such compliance programs establish corporate governance for parity compliance, identify discrepancies in coverage of services for the treatment of mental health conditions and substance use disorder, and ensure appropriate identification and remediation of improper practices. By December 31, 2021 and annually thereafter, each insurer shall electronically submit a written certification to the superintendent that the insurer satisfactorily meets the requirements of parity compliance program.

NYSPA submitted comments in general support with additional recommendations:

- Instead of annual certification, Department of Financial Services should establish instead an attestation to be completed as part of the annual SERFF rate and form submission process. This way, insurers would be required to attest up front that their products comply with the requirements of parity program rather than after the fact.
- Establish fines and penalties for non-compliance.
- Move up the effective date of compliance from December 21, 2020 18 months away.

# VIII. 3-Hour CME Requirement on Pain Management – Attestation or Re-Attestation Now Due October 1

As part of NY's I-STOP law, prescribers licensed in New York who have a DEA registration number to prescribe controlled substances, as well as medical residents who prescribe controlled substances under a facility DEA registration number, are required to complete at least three (3) hours of course work or training in pain management, palliative care, and addiction. The course work or training must be completed once every three years, and an attestation confirming completion made to the Department.

Due to the impact of Novel Coronavirus – COVID-19 in NYS, prescribers who were due to attest or re-attest between June 30, 2020 and September 30, 2020, now have until October 1, 2020 to complete the required coursework or training and attest or re-attest. # IX. NYSPA VMH-PCTI Update

NYSPA's VMH-PCTI continues to work. The latest edits to the webinar recordings of NYSPA's VMH-PCTI tracks on PTSD/TBI and veteran suicide and suicide prevention have been made and we are working to have them uploaded to the NYSPA website for individuals to view in compliance with the CME rules and procedures. We expect to have both webinar recordings uploaded to NYSPA website shortly and plan to send out a notice/advisory to the primary care specialty societies to alert their members.

In addition, NYSPA's VMH-PCTI presentation on military culture has been finalized and we are working with the developer of the presentation to schedule a time to record the presentation, which will be available on the NYSPA website. NYSPA's VMH-PCTI is also working to finalize the women veterans' issues PowerPoint and looking to schedule a train-the trainer session.

Richard Gallo and Marianne Goodman, M.D., Coordinator of VMH-PCTI Curriculum, continue to participate in the New York State Division of Veterans' Services Policy Academy: Governor's Challenge to Prevent Suicide Among Service Members, Veterans, and their Families. A contingent of those appointed to the policy academy will go to Washington DC in June for VA/SAMSHA's VA/SAMHSA Governor's Challenge to Prevent Suicide Among Service Members, Veterans, and their Families. Work with the Governor's challenge is ongoing and we have provided them with the PowerPoint presentations of NYSPA's presentation tracks on PTSD/TBI and veteran suicide and suicide prevention.

# X. Other News of Interest

A. "State Mental Health Office to offer virtual group therapy," Rochester Business Journal, June 12, 2020

OMH is launching COVID-19 Coping Circles, a free six-week support and resilience groups held virtually (by phone or video) with up to six individuals and a facilitator who is NYS-licensed independent mental health professionals (creative arts therapists, marriage and family therapists, mental health counselors, psychiatric nurses, psychiatric nurse practitioners, psychiatrists, psychoanalysts, psychologists, and social workers). The facilitators are drawn from the pool of mental health professionals who responded to Governor Cuomo's call for mental health professionals to assist New Yorkers. B. "NY insurers, citing COVID-19 costs, seek double digit rate hikes in 2021. Check your plan" *Rochester Democrat & Chronicle*. June 8, 2020

Health insurers have submitted their 2021 premium rate requests to the Department of Financial Services, seeking an average rate increase of 11.7% in the individual market and 11.4% in the small business market. Department of Financial Services will now review the requests and announce a decision later this summer. In the past, DFS has lowered the rate hikes sought by insurers. *Democrat & Chronicle* notes, "Last year, for example, the insurers sought an average 9.2% rate increase, but the state cut it to an average of 6.8%."

NY Health Plan issued a statement on the proposed rate increases "reasonable and fair." Insurers maintain rate increases due COVID-19 expenses, rising health care costs and preparing for pent up medical demand as elective surgeries and procedures had been prohibited and residents sheltered in place. Citing The Potential National Health Cost Impacts to Consumers,

Employers and Insurers Due to the Coronavirus (COVID-19), HPA document states, "Potential COVID-19 costs for 2020 could range from about 2 percent to over 21 percent of premium if the full first-year costs of the epidemic had been priced into the premium." Breakdown from DFS:

# XI. Status of Members in Senate & Assembly: Retirements & Upcoming Primary Elections

Ten of the 22 current members of the Senate Republican conference have announced they are not running for re-election, including: Senator Ken LaValle, Senator John Flanagan (current minority leader), Senator Elizabeth Little, Senator George Amedore, Senator James Seward, Senator Rich Funke, Senator Joseph Robach, Senator Chris Jacobs (running for Congress in 27<sup>th</sup> District), Senator Michael Ranzenhofer and Senator Joseph Griffo. On the Democratic side, Senator Velmanette Montgomery is not running for re-election while Senator David Carlucci is fighting in a crowded Democratic primary for a chance at filling the seat held by retiring U.S. Representative Nita Lowey.

While Senator John Flanagan (R), current Minority Leader, had announced he was not running for re-election, he announced today he would resign his position early on June 28, 2020 to take a position as Vice President of Regional Government Affairs for Northwell Health focusing on working with Suffolk County and federal officials.

Democratic Presidential, Congressional and State Legislative primaries are scheduled for Tuesday, June 23, 2020. Governor Cuomo issued an executive order requiring the Board of Elections to send all registered voters an absentee ballot application with postage paid for return to allow individuals to vote via absentee in the primary elections. As such, voters will have the

ability to vote in person or via absentee ballot. Of note from Governor Cuomo's office "Completed absentee ballots must be postmarked by Tuesday, June 23<sup>rd</sup> or delivered in person to the voter's County Board of Elections location before 9:00PM on Tuesday, June 23<sup>rd</sup>." Early voting is from June 13 to June 21. There are a number of hotly contested primary races for Congress, Senate and Assembly. In many of the primary elections, winning the primary is tantamount to winning the election. The pertinent committee chairs in the Senate and Assembly are not facing primary election challenges.

The elections are not likely to change the balance of power as Democrats hold 40 of 63 seats in the Senate and 104 (upwards of 107) of the 150 seats in the Assembly.





# Q6 How has your practice volume been impacted by the public health emergency (select all that apply)?





# Q7 How has your overall practice been impacted by the public health emergency (select all that apply)?



# Q8 Have you provided volunteer psychiatric services during the public health emergency?








# Q9 During the public health emergency, which membership organizations and available resources have you found helpful and instructive (check all that apply)?

# Q10 Have you received CARES Act stimulus money from HHS?



# Q11 If YES, have you applied for the second round of funding?



# Q12 Once the public health emergency has passed, do you anticipate that you would choose to operate any portion of your practice via telemedicine?





# DRAFT PROPOSAL FOR NEW YORK STATE PSYCHIATRIC ASSOCIATION (NYSPA) FROM PROFESSIONAL RISK MANAGEMENT SERVICES (PRMS)

PRMS confirms an exclusive Platinum Level Sponsorship of the NYSPA website with a sponsorship fee, web content and other support to NYSPA. Our proposal requires that PRMS be the only medical malpractice insurance company at this level of sponsorship.

### Advertising: \$2,500

- 1. Ad exclusive to PRMS on homepage (and on other agreed upon pages) of NYPSA website
- 2. Partnership prominently listed on website in addition to banner ad
- 3. Ads to appear in at least four e-bulletins sent out by NYSPA to its membership
- 4. Priority placement over competitor of PRMS advertisements in newsletter or e-bulletins
- 5. Opportunity to provide information to be included in a NYSPA email blast(s) with first right of refusal over other PRMS competitors

### B. Mailing List: \$1,000

- At the request of PRMS, two NYSPA membership mailing lists will be made available to the mailing house chosen by PRMS. Materials being sent will be subject to NYSPA's approval, which should not be unreasonably withheld.
- 2. NYSPA will send two emails during the partnership term to all members on behalf of PRMS.
- 3. NYSPA will send two emails during the partnership term to ECP members and RFMs on behalf of PRMS.

### C. Program Support: \$21,500

- 1. Sponsorship of the Spring Area II meeting (Upon NYSPA's approval, opportunity for additional benefits based on 2020 live event cancellation due to COVID-19)
- 2. Opportunity to present at least one webinar\* to NYSPA members on a mutually agreed upon topic (NYSPA to provide webinar-hosting technology and share contact information for attendees with PRMS) \*PRMS is unable to permit webinar recordings for risk management topics due to the timeliness of subject matter.
- 3. Sponsorship of an ECP "meet and greet," educational event, or webinar on a mutually agreed upon topic
- 4. Sponsorship of an RFM "meet and greet," educational event, or webinar on a mutually agreed upon topic
- 5. At such events, acknowledgement of PRMS sponsorship

### D. Other member benefits provided by PRMS

- 1. Non-PRMS insured NYSPA members receive a 20% discount on the registration fee to attend a PRMS national seminar and/or webinar.
- 2. Quarterly risk management tip/alert specifically for residents for a NYSPA email blast or other use.
- 3. Upon request of NYSPA, PRMS will use its Twitter feed for co-promotions (e.g. promote a NYSPA event).
- 4. Case of the Quarter column drawing on PRMS's extensive psychiatric-specific claims data will be provided for Risk Management section of NYSPA website.

- E. A total of \$25,000 will be made payable to the New York State Psychiatric Association upon acceptance of this agreement.
- F. The term of this agreement shall be June 1, 2020 May 31, 2021.
